Who is at risk from the SARS-CoV-2 virus

- The W.H.O. and Australian Health Department claim those who are at high risk of severe COVID-19 are the elderly or others with lung or heart disease, diabetes or other conditions that affect their immune system¹. Yet, the ongoing trials of the AstraZeneca, Novavax and Pfizer vaccines, all scheduled for Australia, mainly involve healthy participants. The "high risk" groups are grossly underrepresented or excluded.

How safe are the COVID-19 vaccines?

- The **Pfizer** vaccine has been given "provisional" approval², and yet the trial is ongoing for another two years³. Some people have experienced **severe allergic reactions**⁴.
- The **Novavax** trial is expected to be completed in 2022³, well before a valid assessment can be made concerning hypothesised **vaccine-induced autoimmunity**, referred to in the trial protocol⁵.
- One of the **AstraZeneca** vaccine trials isn't expected to be completed until 2023³. The vaccine insert states "**Very rare events of demyelinating disorders have been reported following vaccination**"⁶.

Australians are part of a global human vaccine experiment that can hardly answer the question "what are the long term side effects?"

- The Australian government has "invested" \$3.2 billion into COVID vaccines⁷. Yet the TGA and FDA have admitted that they **do not yet know if the vaccines will reduce transmission of the virus**⁸. Many conflicts of interest are not disclosed by governments that promote vaccines⁹.

Why is there censorship?

- **The censorship, suppression of information, and frequent ridicule** of those who speak for freedom of choice or greater transparency, has prevented valid concerns being heard. Governments have established a particular narrative within the media, and any contrary views, even from medical and scientific specialists, are not broadcast.
- Extreme COVID control measures have caused **international and local Doctors, Scientists, Medical Specialists and practicing Health Professionals to voice their concerns** about the damaging consequences of government policies.

As at 6 March 2021, The *Great Barrington Declaration* from epidemiologists, has **55,161 signatures (and growing) from Scientists and Medical Practitioners globally**, who recommend an approach they call "Focused Protection". Groups of Lawyers in Australia and around the world are taking court actions against government interventions¹⁰.

Why is government spending billions of dollars on experimental vaccination when:

- a) other means to protect against severe disease such as vitamins and minerals, nutritious diet, exercise, etc. to improve immunity should have been subject of well-funded health education years ago.
- b) some proposed treatments should receive similar publicity and approval for experimental use¹¹.
- c) the great majority of the community are not at risk of severe illness, as stated by the W.H.O.¹².
- d) not only are most infections not severe but even as much as 43% of infected people don't get sick¹³.
- e) infected children seldom become ill or transmit the virus. So mass vaccination of children is not justifiable¹⁴.



What are your rights?

As per the Australian Immunisation Handbook¹⁵, risks and benefits of a vaccination must be explained for valid informed consent. It is not possible to give valid or informed consent to a vaccination when the risks or even benefits are undetermined.

What legal action can you take?

If you feel pressured or COERCED to be vaccinated, wear a mask or take a PCR test against your will, help is available. Contact the legal team **AdvocateMe.com.au** to join one of their class actions and/or get access to their letter templates.

 - According to The World Health Organisation, the vulnerable and high risk groups are: "people who are older than 60 years or who have health conditions like lung or heart disease, diabetes or conditions that affect their immune system." <<https://www.who.int/westernpacific/emergencies/covid-19/information/high-risk-groups>>.
 - The Australian Health Department state: "The most important risk factor for severe COVID-19 illness is older age. Risk increases substantially above 70 years of age.  - According to the ABS, out of 682 deaths in Australia deemed "COVID-19" deaths, 496 of them had pre-existing chronic conditions and 8 of them were suspected COVID-19 but the presence of the virus was not confirmed [28]. "Among these 496 deaths, dementia was noted on 41% of death certificates, chronic cardiac conditions on 32%, diabetes on 17% and hypertension on 16%" <<https://www1.racgp.org.au/newsgp/clinical/more-than-70-of-covid-19-deaths-had-pre-existing-c>>

Calculated from PCR tests done on people from a cruise ship: Total people infected = 712. Total PCR positive people on the ship without symptoms = 410 ie 58% (410/712) Of those 410, 311 stayed well. ie. 75%. (311/410 x 100). 43% of all the people infected stayed well. (311/712 x 100)"

14. In a paper published earlier this month, University of Queensland virologist Kirsty Short and colleagues examined COVID-19 transmission in households to determine if an adult or a child introduced the disease to the home.
